## Top News: Perkins Extension Bill



- Bipartisan, "clean" 2-year extension expected today.
- Sponsors: Rep. Elise Stefanik (R-NY) and Mark Pocan (D-WI)
  - Cosponsors include:
    - Mark DeSaulnier (D-CA)
    - Illena Ros-Lehtinen (R-FL)
    - Jeff Duncan (R-TN)
    - Louise Slaughter (D-NY)
- No budgetary offsets
- No return of graduate eligibility, etc.





#### The Future of Perkins Loans




- Goal Reauthorization: Long-term Stability & Growth
- If Reauthorization of HEA is NOT completed by 9/30/17:
  - Perkins Champions are prepared to fight for another extension
    - Congressional Members in the House and Senate
    - Higher Education Groups National & Regional
    - Schools & Students Critical for Success
  - We must address the Cost issue for an Extension of Perkins
- If Perkins Expires on 9/30/17 (No Extension/No HEA):
  - Loans for AY 2017-18 can be disbursed through 6/30/18 (As long as 1<sup>st</sup> disbursement occurs by 9/30/17)
  - Schools will be able to service their loans at least for a limited time
  - It can be Revived It's happened before!!

## The 115th Congress



#### House

- 241 Republicans
- 194 Democrats
  - Previous: 247-188
- Majority controls agenda
  - Majority always rules unless it is divided
  - Which it probably will be

#### Senate

- 52 Republicans
- 48 Democrats
  - Previous: 54-46
- Majority sets agenda
  - 60 votes needed to move legislation forward
  - Major exception:
    - "Budget Reconciliation"

## **Perkins Champions**



#### **Senate:**

15 Senators gave speeches on the Senate floor September – December 2015 in favor of extending Perkins – Unprecedented Support! 12 Remain in the Senate

Note: Two Republican senators who spoke for Perkins were defeated for re-election: Senator Ayotte of New Hampshire and Senator Kirk of Illinois; Senator Reid, Nevada Democrat, retired.

## **Higher Education Act Rewrite**



- Reauthorization on hold while confirmations proceed
  - Partisan fights over confirmations, ACA repeal make cooperation hard for a while
- Congress also wants to know Administration views in more detail and precision
- Bills and ideas will continue to come out from Congress members
- Piecemeal approach or comprehensive bill?
- When will it happen?

#### **Perkins Points**



- "Skin in the game": Perkins is a long-established risksharing program where campuses put up their own money
- Local Control of Funding: Campuses allocate loan funds to students with need on an individual basis according to the situation on the campus and with the student
- Local Responsibility for Management: Perkins is managed by campuses in every state
- Reduced Role for Washington: Campuses can manage Perkins portfolios without the need for large numbers of Department of Education staff involved

#### **Perkins Challenges**

COHEAO NORE EDITION FOR MORE EDITION FOR MORE

- Chairman Alexander
- Desire to simplify
- Budgetary issues
  - Extending current program scored as cost by CBO
  - Not logical, but real -- \$4-5 billion over 10 years
  - COHEAO working with Budget Committees on this problem, seeking solutions.
- Desire (among some) to eliminate federal programs





#### **HEA Reauthorization: Campus Flex**







- Campus Flex: COHEAO idea to merge campus-based programs, unify allocation formulas, broaden availability to more campuses
- Best way to extend Perkins
- Funding needed for graduate students
- Need support from other associations

## **Shifting Gears from Perkins**





#### Reconciliation: Means to an End



- "Budget reconciliation" process is used to avoid Senate filibusters
  - Reconciliation Bill can be brought up by leader when he wants, debate ends after 50 hours
  - Effectively means it takes 50 votes plus Vice President to pass a reconciliation bill, not 60 like normal
  - Republicans can pass bills with no Democratic votes
  - Key Senate restriction, Byrd Rule: only provisions that affect spending or revenues allowed. Three-fifths majority can waive that rule, but it seldom happens.

## **Budget Resolution(s)**



- Congressional Budget Resolution: not a law, just rules; sets general spending levels; sets up reconciliation
- Two resolutions this year, for FY2017 and FY2018
- First: already passed, called for reconciliation to repeal ACA (aka "ObamaCare")
- Second: ???

#### **Student Loans & Reconciliation**



- Potential for Direct Loan changes via budget reconciliation.
  - Exactly which reconciliation bill remains unclear
  - Potential reforms include PLUS caps or elimination; possible elimination of Subsidized Stafford Loans; and perhaps other proposals
  - As mandatory programs, Stafford and PLUS always potential targets in reconciliation bill
- Other HEA mandatory spending includes a portion of Pell,
   Challenge Grants, and Title III (MSIs)

## Trump Campaign Higher Ed Ideas



- IBR 12.5% of income per month, forgiven after 15 years
- No profit on student loans
- Colleges should use endowments for student aid or face taxes
- Federal government should not be in student loan business
- Better cost info to students and "free speech on campus"
- Eliminate regulations, burdens on colleges
- Eliminate or cut Dept. of Education

# Trump "Skinny Budget" on Higher Ed

WORE FOR MORE AND A STAOR STAO

- No mention of Perkins Loans
  - SEOG eliminated
  - FWS faces significant cuts
  - References to "fairness" issues with allocation formula in Campus-Based
- Part of Pell surplus put toward deficit reduction
- Cuts for Trio and GEAR-UP
- No mention of mandatory programs, including Direct Loans
- Significant non-defense cuts generally
- Appropriators describe it as "DOA"

## Department of Education Staffing



- Transition underway at Education Department: Secretary, Under Secretary, Deputy Secretary, Assistant Secretaries, Deputy Assistant Secretaries -- 150 political appointees
- Undersecretary will be responsible for higher education
  - James Manning currently serving in Acting Capacity. May have job on a permanent basis
- Career civil servant Lynn Mahaffie appointed acting undersecretary, acting assistant secretary for postsecondary education

#### **Department of Education Issues**



- Expect K-12 focus, but with permanent staff now on board, may be able to do more on higher education
- Regulatory Relief
  - General regulatory relief effort
  - Decisions on what to enforce (i.e. Gainful Employment, Defense to Repayment
- Operational Issues
  - DRT
  - Direct Loan administration
